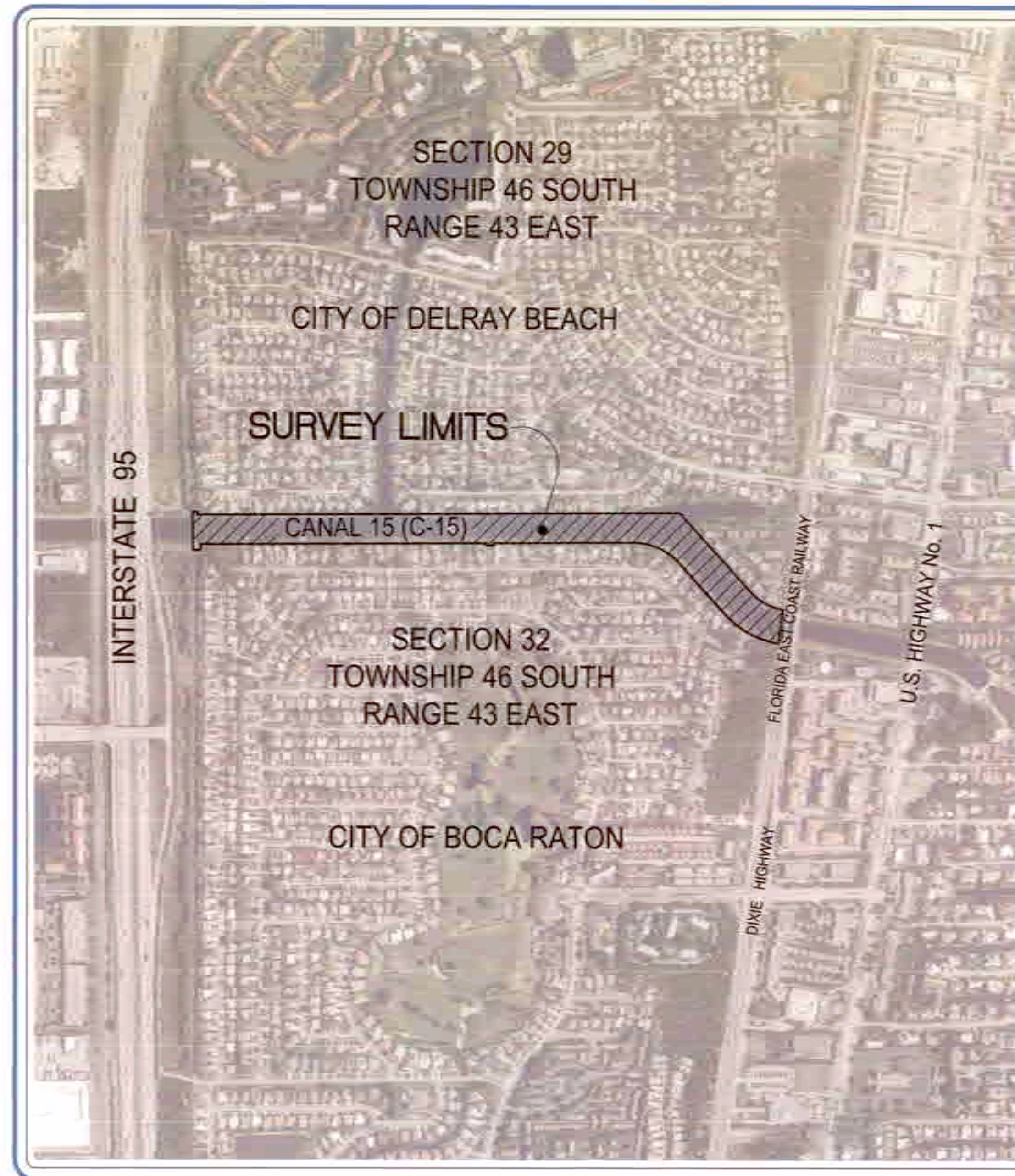

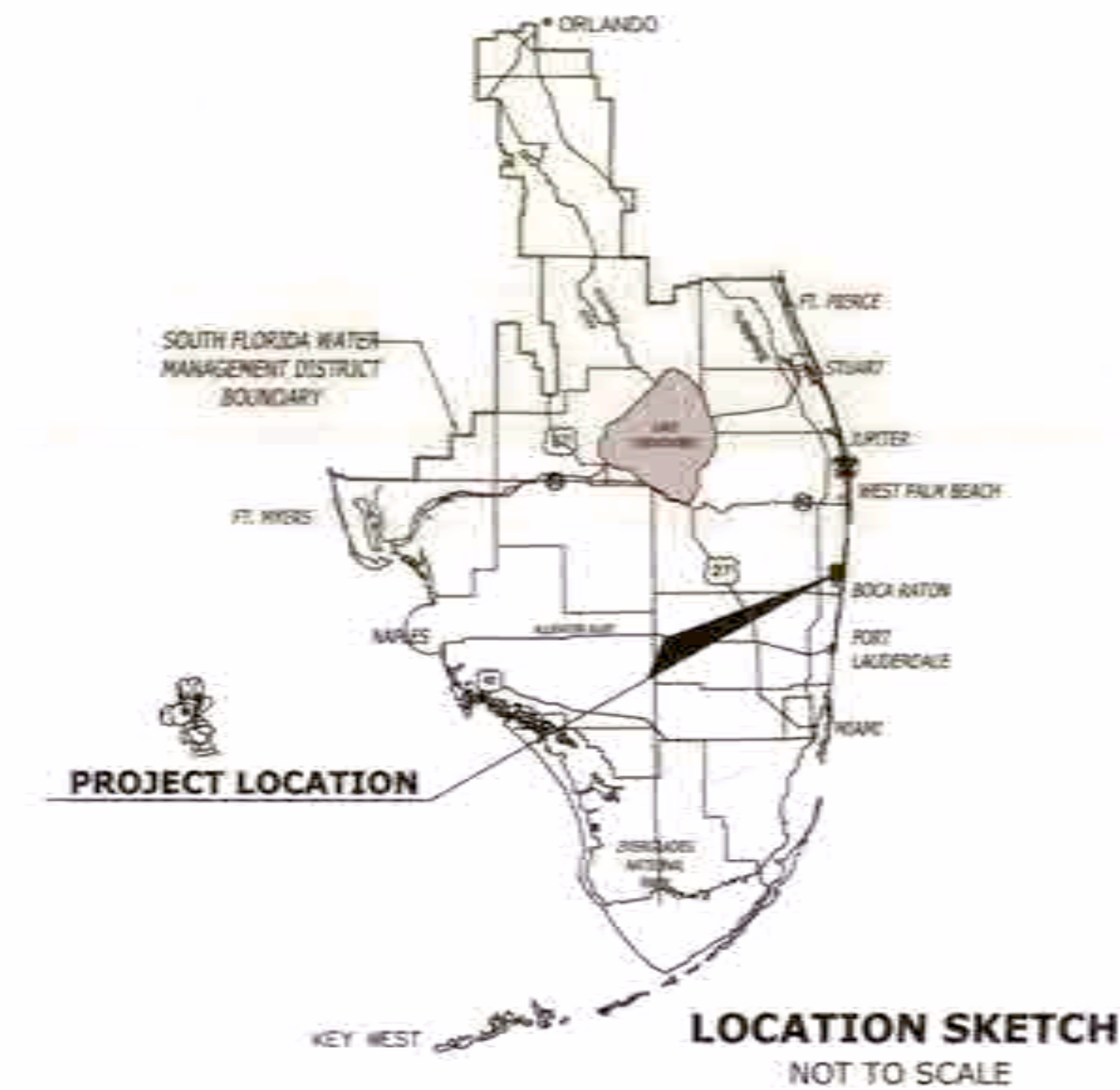

4. All measurements are the same as on record unless otherwise noted.
5. Whidden Surveying & Mapping, Inc., Certificate of Authorization No. 7232, is issued by the Florida Department of Agriculture and Consumer Services, Board of Professional Surveyors and Mappers.
6. This sketch has been prepared for the exclusive use of the entities named hereon and does not extend to any unnamed party.

All bearings shown hereon are grid bearings, 1983 North American Datum (2011 adjustment), Florida East Zone, said bearings based on a line between National Geodetic Survey (NGS) published control points "C 234 1965" & "APWEST", said Line line bears South 01°05'32" East and all other bearings recited hereon are relative thereto.
8. This is a Boundary Survey as defined in Chapter 5J-17.050(10)(a)-(k), Florida Administrative Code and locations are limited to visible improvements only. Underground utilities, if shown, are based on information provided by the various utility companies and these locations may vary and therefore should be considered approximate. There may be additional underground utilities not shown on this drawing. No excavations were made to locate buried utilities.
9. This survey does not reflect nor determine ownership.
10. Horizontal control points utilized for this Survey are as designated: National Geodetic Survey (NGS) point "C 234 1965", a second order Horizontal and second order class II Vertical point, National Geodetic Survey (NGS) point "APWEST", a second order Horizontal point. 11. Receivers used for GPS measurements: Trimble RB-3 & SPS 985 dual frequency carrier phase receivers, in "real time kinematic" (RTK) mode.
12. Horizontal values and coordinates presented on this survey are referenced to the State Plane Coordinate System, Florida East Zone, NAD 1983, (2011 adjustment U.S. Survey Foot).
13. Procedures and network design meet or exceed standards and specifications for using GPS relative positioning techniques as set forth by the Federal Geodetic Control Committee (FGCC).
14. All set monuments are a 30 inch minimum length, 1-1/4 inch diameter steel pipe encased in concrete with a 2" South Florida Water Management District aluminum disk stamped: "C 15 R/W 2017"
15. Aerial photograph shown hereon was obtained from the Florida Department of Transportation website and has a flight date of January 2015. These photographs are for general information and may not reflect current conditions.
