### III. Approval of Minutes from the September 27, 2021 meeting

Jonathon Ricketts motioned to approve meeting minutes

Commissioner Jenkins, Martin County, wanted the members of LRMCC to be aware of a proposed Referendum for a one cent sales tax to be used for the purchase of environmentally sensitive lands. Chairman Albrey asked for additional back up information for LRMCC members to review before determining LRMCC involvement. The Chair asked Kathy to add this to the agenda as a standing item

# VI. Project Updates

- A. Lainhart & Masten Dam Update Octavio Castillo (15 min)
  Jim Shuette, SFWMD, stated that repairs are in progress with a NTP in March 2002. The work should be complete by June 30, 2022. Passed around a sample of the composite lumber that will be used.
- B. Loxahatchee River Wild and Scenic Management Plan Update Barbara Welch (30 min) Barb is assembling the chapters with assistance from Dick and Merriam. It was decided that as the chapters are completed, they will be sent out for review and comment by LRMCC members. LRMCC Chapter reviews will be done through Kathy. The chapters may not be in sequential order. Albrey gave another pep talk for agency representatives to submit their information to Barb.

## VII. Watershed Status Updates

- A. MFL Status Update Albrey Arrington, LRD (5 min)
  No violations this year (2022) Albrey discussed SFWMD Rainfall graphs comparing them from May 2020 December 2021. It appears SFWMD is doing a better job at managing flows to the Northwest Fork of the Loxahatchee River to avoid MFL violations.
- B. Water Quality, Bud Howard, LRD (10 min) Bud was not present and Albrey referred to the Loxahatchee River Environmental Control District website for recent water quality results.

### VIII. Potential LRMCC Membership - DD Hapern

Chad Kennedy had researched the Palm Beach Pack and Paddle Club (PBP&PC) to determine if it is still an active organization. Allen Treffer, former Palm Beach County ERM staff, has been asked by PBP&PC to represent the organization on the LRMCC. Deb Drum provided her support of the selection. Allen was present at this meeting.

It appears that neither SFWMD nor FDEP would be appointing an At Large representative at this time.

Gregg Braun suggested that DD Hapern coordinate with Herb Zebuth, representative of the Palm Beach County Env. & Conservation Groups and ask to be his alternate on the LRMCC.
