Subject: South Florida Water Management District Adopted Budget Submission for Fiscal Year 2023-24

Dear Governor DeSantis, President Passidomo, and Speaker Renner:

The South Florida Water Management District Governing Board respectfully submits its Adopted Budget for October 1, 2023 – September 30, 2024 (Fiscal Year 2023-24) of \$1,226,876,797 pursuant to Section 373.536, Florida Statutes. This Adopted Budget continues to support Governor DeSantis' *Achieving Even More Now for Florida's Environment* Executive Order 23-06 to advance Everglades restoration, water resource resilience, and improve water quality.

With historic support from Governor DeSantis and the Florida Legislature including the Legislative Budget Commission, the Adopted Budget for Fiscal Year 2023-24 includes 61 percent in state revenues which allows the District to expedite progress on critical Everglades restoration, water infrastructure resilience, and water quality improvement projects. The District also continues to deliver on management of South Florida's primary water management infrastructure that provides flood control and water supply for over 9 million residents and tens of millions of visitors. The Fiscal Year 2023-24 Adopted Budget supports the agency's mission: "To safeguard and restore South Florida's water resources and ecosystems, protect our communities from flooding, and meet the region's water needs while connecting with the public and stakeholders."

This is accomplished through mission-critical functions including:

<u>Restoration and Water Resource Resilience</u> by Safeguarding and Restoring South
 Florida's Delicate Ecosystem by expediting restoration projects and expanding the water
 quality monitoring network;

- <u>Flood Protection</u> by Protecting South Florida's Communities from Flooding, Ensuring and Management Water Flow by refurbishing, replacing, improving, and managing the components of South Florida's primary water management system; and
- <u>Water Supply</u> by Ensuring Water for South Florida's Communities by meeting the water needs of the environment and preparing for current and future demands of water users.

Our Governing Board continues its commitment to increase transparency, accountability and fiscal discipline while maintaining the necessary public service needed to protect and improve South Florida's water resources. Quick Facts on the Oct. 1, 2023-Sept. 30, 2024 Fiscal Year Budget



The South Florida Water Management District Governing Board's Adopted Budget is \$1.23 billion for the 2023-2024 Fiscal Year. The budget continues to support Governor Ron DeSantis' Achieving Even More Now for Florida's Environment Executive Order 23-06 to advance Everglades restoration, water resource resilience, and improve water quality.

Budget Highlights

More than \$620 million to continue Everglades and ecosystem restoration progress.

- Completing the Everglades Agricultural Area (EAA) Reservoir Project's Stormwater Treatment Area
- Completing the 13-year Restoration Strategies program, sending cleaner water to the Everglades
- Completing the CEPP New Water Seepage Wall in the 8.5 Square Mile Area
- Breaking ground on the C-23/C-24 South Reservoir for the protection of the St. Lucie Estuary and Indian River Lagoon
- Building additional components of the Central Everglades Planning Project
- Continuing to implement the Lake Okeechobee Watershed Restoration Project
- Awarding the final contract for the Biscayne Bay Coastal Wetlands Project
- Continuing to make progress on the Caloosahatchee (C-43) Reservoir Project

More than \$315 million to upgrade and maintain water management infrastructure that makes up the regional flood protection system and the operations of new infrastructure associated with completed Everglades restoration projects.

- Over \$84 million for refurbishments of the flood protection system
- Over \$56 million for hurricane/tropical weather impacts or unanticipated flood protection emergencies

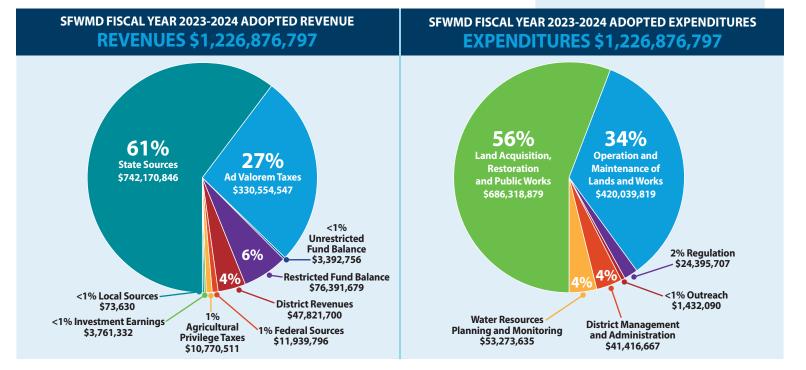

Revenue Sources and Adopted Millage Rates

- The annual budget is funded by a combination of ad valorem (property) taxes and other revenues such as state appropriations, federal and local sources, fees, investment earnings and agricultural privilege taxes.
- The millage rate for the 2023-2024 Fiscal Year represents \$23.01 per \$100,000 of taxable value in 15 of the District's 16 counties (Okeechobee Basin).
- The millage rate for the 2023-2024 Fiscal Year represents \$19.26 per \$100,000 of taxable value in Collier and mainland Monroe counties (Big Cypress Basin).
