Andrew ("Andy") D.W. Hill was appointed to the Big Cypress Basin Board December 2020 by Governor Ron DeSantis. Hill has more than 30 years of portfolio management experience. He is the President of Andrew Hill Investment Advisors, a boutique investment advisory firm that he co-founded with business partner Jennifer Figurelli in 2010. Over the ten years in business, the firm has grown to manage over \$100 million in client assets. In addition, Hill is a frequent speaker on the integration of environmental, social, and governance issues into equity research.

Prior to forming his own firm, he was a Senior Portfolio Manager and regional Chief Investment Officer with two regional Trust banks. While at both institutions, Hill served in various nationwide investment strategy capacities including forming asset allocation recommendations and political research.

Hill holds a Master's degree in Business Administration from Syracuse University and a Bachelor of Science degree from Canisius College. He is a Chartered Financial Analyst. He is a Past President of the Financial Analysts Society of Naples. Hill was inducted into the Sigma Beta Delta International Honor Society and inducted into the Canisius College DiGamma Honor Society.
