SUBJECT: Operational Position Statement for June 5, 2018 to June 11, 2018

This Position Statement is for the one-week period from June 5, 2018 to June 11, 2018. On June 4, 2018, Lake Okeechobee stage was 14.23 feet NGVD, in the Low Sub-band, within 1.0 feet of the intermediate Sub-band. Lake stage increased by 0.33 feet during the preceding 7 days.

District rainfall for May was well above average (301% of normal), while rainfall for the first days of June has been below normal. District forecast (issued June 5) predicts slightly below average rainfall for the coming week and below average for most of the District areas for the second week, but slightly below average for the Kissimmee Valley.

<u>Precipitation Outlook:</u> The most recent Climate Prediction Center (CPC) precipitation outlook for June 2018 indicates equal chances of below-normal, normal and above-normal rainfall for the District. The outlook for the 3-month window Jun-Aug is for slightly increased chances of above normal rainfall (~ 37%). For the Jul-Sep window, the area north of the lake exhibits slightly increased chances of above normal rainfall (~ 37%), while the rest of the District has a precipitation outlook for increased chances of above normal rainfall. The 3-month windows from Oct-Dec 2018 to Jan-Mar 2019 show increased likelihood of above normal rainfall. For 3-month windows not specified here (e.g. Aug-Oct), the outlooks are for equal chances (EC) of below-normal, normal and above normal precipitation.

<u>2008 LORS Release Guidance (Part C)</u>: With Lake Okeechobee stage within the Low Sub-band, the Tributary Hydrologic Conditions in the Very Wet category and the Multi-Seasonal Lake Okeechobee Net Inflow outlook in the Wet category, Part C of the 2008 LORS release guidance recommends "Up to maximum practicable releases to the WCAs if desirable or with minimum everglades impacts". Otherwise no releases.

Over the 7-day period from May 28, 2018 to June 3, 2018, there were no releases south from Lake Okeechobee to any of the STAs, FEBs or to tide through the C-51 canal due to heavy rainfall the prior week and USACE requesting the SFWMD make no regulatory releases from the lake south to the WCAs. Stage at gauge 1-8C in WCA-1 is in Zone A1 of the regulation schedule. Stage in WCA-2A (S-11B HW) is above the regulation schedule. Stage in WCA-3A is in Zone A. For the coming operational period, the USACE is requesting the SFWMD make no regulatory releases from the lake south to the WCAs.

<u>2008 LORS Release Guidance (Part D):</u> With Lake Okeechobee stage within the Low Sub-band, the Tributary Hydrologic Conditions in the Very Wet category, lake stage within 1.0 feet of the Intermediate Sub-band, and the Seasonal Lake Okeechobee Net Inflow outlook in the Very Wet category, Part D of the 2008 LORS release guidance suggests: "S-77 up to 4,000 cfs and S-80 up to 1,800cfs".

Total discharge to the St. Lucie Estuary averaged around 5,500 cfs over the past week with approximately 600 cfs coming from Lake Okeechobee. The 7-day average salinity at the US1 Bridge increased slightly but is still in the poor range for adult oysters. Total inflow to Caloosahatchee Estuary averaged approximately 7,350 cfs over the past week with 1,900 cfs coming from the Lake. Salinity conditions between Val I-75 and Ft. Myers remain good for tape grass. Salinity is in the good range for adult oysters at Shell Point and in the fair range at Cape Coral.

Lake Okeechobee stages continue to increase from recent rainfall associated with the May 2018 extreme rainfall conditions. The District recommends that the Corps follows the LORS 2008 Regulation Schedule, with consideration for local basin runoff, for the coming operational period.
