PJ Smith is a real estate broker and the owner of Naples Golf to Gulf Real Estate and currently serves as President Elect of the Naples Area Board of Realtors (NABOR).

She has worked as a State Urban Planner for the State of Minnesota, specifically the Capitol Area Architectural Planning Board (CAAPB). This position included work on various construction projects such as the Judicial Building, History Center, and Capitol restoration projects. CAAPB coordinated international design competitions, updated regional comprehensive plans including land use studies and planning, championed local zoning ordinance revisions, and worked with the federal government on interstate highway enhancements.

Smith served as Executive Director for two state regulatory agencies for the State of Minnesota within the healthcare industry for four years before moving into the private healthcare industry. Her advanced education and experience in alternative health care led to ownership in three healthcare businesses and national recognition for an innovative product. This spanned over 25 years which included owning commercial and investment real estate in Minnesota and Florida.



Smith has been licensed in real estate in Florida since December 2016. She currently serves as a Florida Realtors Director (with 225,000 members) and a National Association of Realtors (NAR) Director (with 1.65 million members). She was honored to be selected as one of 95 members of NAR to serve as Vice Chair of the 2024 NAR Land Use, Private Property Rights and Environment Committee after serving as a member of that committee and the subcommittee on water resources since 2019.
