Blank cells in TP concentrations indicate NOB due to no-flow (gate closed) or too shallow water depth (less than 0.1 m) except for S328. S328 is on a bi-weekly sampling schedule as indicated in note number 1.

G: Analyte was detected at or above the method detection limit in both the sample and the associated field blank, equipment blank, or trip blank, and the blank value was greater than 10% of the associated sample value.

Y: Analysis was from an improperly preserved sample.

J: Sample was taken from a disconnected pool and was not representative of the surrounding wetland.

"-" in flow data indicates the value was negative and zeroed out in the calculations.
