5 **A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH**
6 **FLORIDA WATER MANAGEMENT DISTRICT APPROVING THE**
7 **TENTATIVE MILLAGE RATES FOR THE SOUTH FLORIDA WATER**
8 **MANAGEMENT DISTRICT AND THE BIG CYPRESS BASIN OF THE**
9 **SOUTH FLORIDA WATER MANAGEMENT DISTRICT FOR THE**
10 **FISCAL YEAR 2011-2012; PROVIDING AN EFFECTIVE DATE**

12 **WHEREAS**, the Governing Board of the South Florida Water Management
13 District in compliance with and by authority of Chapters 200 and 373, Florida Statutes,
14 as amended, and Chapter 25270, Laws of Florida, Act of 1949, shall on September 8th,
15 2011, approve its tentative budget for Fiscal Year 2011-2012; and

16 **WHEREAS**, it is determined that a tentative tax levy of one thousand seven
17 hundred eighty-five ten thousandths mill (.1785 mill) (\$.1785 per \$1,000 of assessed
18 value) upon all property lying within the District subject to the District's tax is necessary
19 to provide funds for District budgeted expenditures as set forth in the tentative budget;
20 and

21 **WHEREAS**, it is determined that a tentative tax levy of one thousand six hundred
22 thirty-three ten thousandths mill (.1633 mill) (\$.1633 per \$1,000 of assessed value)
23 upon all property lying within the Big Cypress Basin subject to the Basin's tax is

1 necessary to provide funds for Big Cypress Basin budgeted expenditures as set forth in
2 the tentative budget; and

3 **WHEREAS**, it is determined that the combined total tentative tax levy of the
4 District and the Big Cypress Basin is three thousand four hundred eighteen ten
5 thousandths mill (.3418 mill) (\$.3418 per \$1,000 of assessed value); and

6 **WHEREAS**, the tentative millage rate to be levied by the District for the District
7 tax is 31.45 percent (31.45%) less than the rolled-back rate and said percentage is the
8 percentage decrease in property taxes to be adopted by the District; and

9 **WHEREAS**, the tentative millage rate to be levied by the District for the Big
10 Cypress Basin tax is 32.07 percent (32.07%) less than the rolled-back rate and said
11 percentage is the percentage decrease in property taxes to be adopted by the District;
12 now therefore

13 **BE IT RESOLVED BY THE GOVERNING BOARD OF THE SOUTH FLORIDA**
14 **WATER MANAGEMENT DISTRICT:**

15 **Section 1.** There is hereby tentatively levied a uniform ad valorem tax on all property
16 in the District as determined for county taxing purposes at the rate of one thousand
17 seven hundred eighty-five ten thousandths mill (.1785 mill) (\$.1785 per \$1,000 of
18 assessed value) on the dollar on the assessed valuation of such property.

19 **Section 2.** There is hereby tentatively levied (for purposes other than the Everglades
20 Construction Project) a uniform ad valorem tax on all property in the Big Cypress Basin
21 as determined for county taxing purposes at the rate of one thousand six hundred thirty-
22 three ten thousandths mill (.1633 mill) (\$.1633 per \$1,000 of assessed value) on the
23 dollar on the assessed valuation of such property.

1 **Section 3.** The combined total tentative levy of the District and Big Cypress Basin is
2 three thousand four hundred eighteen ten thousandths mill (.3418 mill) (\$.3418 per
3 \$1,000 of assessed value).

4 **Section 4.** The tentative millage rate hereby levied by the District for the District tax is
5 31.45 percent (31.45%) less than the rolled-back rate and said percent is the
6 percentage decrease in property taxes hereby adopted by the District.

7 **Section 5.** The tentative millage rate hereby levied by the District for the Big Cypress
8 Basin tax is 32.07 percent (32.07%) less than the rolled-back rate and said percent is
9 the percentage decrease in property taxes hereby adopted by the District.

10 **Section 6.** This resolution shall take effect immediately upon adoption [or such other
11 date as is appropriate].
