A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT APPROVING THE TENTATIVE MILLAGE RATES FOR THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT, THE OKEECHOBEE BASIN OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT, AND THE EVERGLADES CONSTRUCTION PROJECT WITHIN THE OKEECHOBEE BASIN FOR FISCAL YEAR 2011-2012; PROVIDING AN EFFECTIVE DATE

WHEREAS, the Governing Board of the South Florida Water Management District in compliance with and by authority of Chapters 200 and 373, Florida Statutes, as amended, and Chapter 25270, Laws of Florida, Act of 1949, shall on September 8th, 2011, approve its tentative budget for Fiscal Year 2011-2012; and

WHEREAS, it is determined that a tentative tax levy of one thousand seven hundred eighty-five ten thousandths mill (.1785 mill) (\$.1785 per \$1,000 of assessed value) upon all property lying within the District subject to the District's tax is necessary to provide funds for District budgeted expenditures as set forth in the tentative budget; and

WHEREAS, it is determined that a tentative tax levy of one thousand nine hundred fifty-four ten thousandths mill (.1954 mill) (\$.1954 per \$1,000 of assessed value) upon all property lying within the Okeechobee Basin subject to the Basin's tax is necessary to provide funds for Okeechobee Basin budgeted expenditures as set forth in the tentative budget; and

WHEREAS, it is determined that a tentative tax levy of six hundred twenty-four ten thousandths mill (.0624 mill) (\$.0624 per \$1,000 of assessed value) upon all property lying within the Okeechobee Basin subject to the Basin's tax is necessary to provide funds for the design, construction, and acquisition of the Everglades Construction Project and for such other purposes as authorized in subsection (4)(a) of Section 373.4592, Florida Statutes; and

WHEREAS, it is determined that the combined total tentative tax levy of the District and the Okeechobee Basin is four thousand three hundred sixty-three ten thousandths mill (.4363 mill) (\$.4363 per \$1,000 of assessed value); and

WHEREAS, the tentative millage rate to be levied by the District for the District tax is 31.45 percent (31.45%) less than the rolled-back rate and said percentage is the percentage decrease in property taxes to be adopted by the District; and

WHEREAS, the tentative millage rate to be levied by the District for the Okeechobee Basin tax (other than for the Everglades Construction Project) is 31.37 percent (31.37%) less than the rolled-back rate and said percentage is the percentage decrease in property taxes to be adopted by the District; and

WHEREAS, the tentative millage rate to be levied by the District for the Everglades Construction Project is 31.43 percent (31.43%) less than the rolled-back rate and said percentage is the percentage decrease in property taxes to be adopted by the District; now therefore
