



Program Statistics (March 25-June 1, 2017)

- Total Pythons: 158
- > Total length: 1,369 feet (roof of Empire State Building=1,250')
- > Total weight: 3,725.2 pounds
- Total hours: 3,003
- Hourly pay: \$24,054
- Cash payment: \$25,450
- Total program cost: \$49,504
- Remaining budget balance: \$125,496









Python Program Phase II Options for Time and Range

Option #1 (status quo)

 Continue the program June 17th through September 30th in current range and scope of work.

Option #2

 Pause the program and restart during colder months (i.e. November 2017 through March 2018) in current range and scope of work.

>Option #3

 Continue the program June 17th through September 30th in Miami-Dade, and expand to Broward and Collier Counties.

Python Program Phase II Options for Bounty Payment

- Option #1 (status quo)
 - Continue on site cash payments.
- > Option #2
 - Bounty payments mailed to participants using existing District vendor check payment system.
- >Option #3
 - Continue cash payments at Homestead Field Station and issue checks at additional drop off locations.

Python Program Phase II Options for Survey Payment

- Option #1 (status quo)
 - Continue \$8.10/hour with maximum of 8 hours/day.
- Option #2
 - Replace hourly payment with flat rate of \$45/day for minimum survey time.
- Option #3
 - Replace hourly payment with per diem of \$35/day for 1-4 hours worked or \$65/day for 5-8 hours worked.

Python Program Phase II Additional changes

- Replace low performing participants with new recruits from prequalified pool (currently evaluating 5 participants).
- Add an additional 10 participants from prequalified pool to bring total program to 35 hunters.
- Field Station drop off times Monday through Thursday and two hours on Saturday. Decreases overtime and increase cost avoidance.
- FWC Executive Order to include new Wildlife Management Areas in additional counties.

Python Program Phase II Staff Recommendations

- Continue the program June 17th through September 30th in Miami-Dade, and expand to Broward and Collier Counties.
- Bounty payments mailed to participants using existing District vendor check payment system.
- Continue \$8.10/hour with maximum of 8 hours/day.
- Recommendations will streamline program processes and increase efficiencies while maintaining current payment to python hunters.
