REQUEST FOR INFORMAL DETERMINATION OF WETLAND AND OTHER SURFACE WATERS

An Informal Wetland and Other Surface Waters Determination is provided as a public service; we will make every effort to complete it in a target of 8 weeks upon receipt of all required information. Please contact the South Florida Water Management District office at 561-682-6736 if you have any questions before requesting an Informal Wetland and Other Surface Waters Determination. Incomplete information will further delay the process. There is a \$250 fee for properties one acre or less in size and a \$500 fee for properties greater than one acre in size. Pursuant to Florida Statute 373.109, an informal determination is not an application for a permit and is not subject to the permit review timeframes established in chapter 120, nor does it constitute final agency action.

Please submit the required information through the District's ePermitting website at http://my.sfwmd.gov/ePermitting/MainPage.do. Payment of application fees can be done by credit card on the District's ePermitting website or by check. If submitted by check, please make the check payable to the South Florida Water Management District and reference the application number in the memo section of the check to ensure adequate processing.

If the intended use of this property is for single-family, please do not submit this form and instead contact the appropriate Florida Department of Environmental Protection District Office. (A link to the FDEP map can be found here: https://floridadep.gov/districts).
