Terrie presented a contract proposal from Lee Chitty, CPA to provide administrative support services to the Committee. There are no changes from previous contracts. Motion was made to approve the contract in an amount not to exceed \$9,500.00 for an estimated 100 hours of support services. Motion passed.

6. L-31N Seepage Barrier Project - Tom MacVicar

Tom summarized a proposal to construct a 2-mile long, 35-foot deep seepage barrier on the west side of the L-31N Canal as Phase 1 in the implementation of the L-31N Seepage Control Project. The estimated cost of construction is \$7,838,000 and the Committee would authorize 150 WRAP mitigation credits. Tom discussed recent activities on the project (updated monitoring plan, responses to SFWMD cost estimates and Corps geotechnical comments) and answered questions from various Committee members. A motion was made to approve funding the construction of a 2-mile, 35-foot deep seepage barrier on the west side of the L-31 Canal as Phase I in the implementation of the L-31N Seepage Control Project in an amount not to exceed \$7,838,000 and to authorize 150 WRAP mitigation credits for the project. Motion passed.
