South Florida Water Challenge

- Lower East Coast Regional Availability Rule passed in 2006 requires all new water to be an Alternative Water Supply or other option described in the rule
- Floridan Aquifer Wells with Reverse Osmosis
 Treatment Very Expensive and Questionable
 Sustainability
- Reclaimed Water to Recharge Aquifers Even More Expensive
- Utilities joined together to evaluate C-51 Reservoir to capture excess storm water and recharge Surficial and Biscayne Aquifers to use existing well fields and treatment capacity
- C-51 Reservoir is preferred after extensive study


C-51 Reservoir Alternative Water Supply

- Water conveyed through a series of SFWMD, Lake Worth Drainage District, and other integrated canal systems
- No structural improvements necessary to deliver Phase 1 water
- Recharges local wellfields



Project History

- Originally contemplated as part of CERP
- ➤ 2006 Coordination of seven Broward and Palm Beach water utilities and counties
- ➤ 2007-2008 Partners cost-shared in initial preliminary design and cost-benefit analyses with policy and regulatory issues coordinated with SFWMD
- ➤ 2009 2013 Regulatory, environmental, geotechnical, conveyance, governance, and financial considerations culminated in the Preliminary Design and Cost Estimate Report


C-51 Reservoir Phase 1

- 14,000 acre-feet static storage
- 39,000 acre-feet dynamic storage
- 35 Million Gallons Per Day (MGD) for Alternative Water Supply
- 35 MGD would serve 233,333 households at 150 gallons per day per capita
- Majority of Excavation Complete
- \$161 million cost derived from Third Party Independent Estimate
- Permits in place, construction plans approved, can be operational 24 months from construction start



Conveyance Routing Lower East Coast

- Final routes not yet final: discussions ongoing as a component of Operating Plan
- Will use existing canals, pumps and structures, with improvements as needed
- Pending Operating Plan follows same approach as existing water supply deliveries to recharge well fields through canals
- 35 mgd is very small amount compared to capacity of canals and existing LEC permitted water supply



Current Capacity Allocation Agreement and Letters of Intent – Total of 35 MGD Available

- Broward County: 6 MGD (Executed Agreement)
- Sunrise: 5 MGD
- Lauderhill: 2 MGD
- Dania Beach: 1 MGD
- Total 14 MGD (21 MGD Remaining)
- Discussions with others in progress
- Opportunity to obtain alternative water supply consumptive use permits for duration of C-51 Reservoir CUP – until December 27, 2065
