3. Review and Approve minutes from 02/08/08 meeting – J. Llewellyn

Minutes were reviewed and amended. Motion to pass minutes, as amended, was

approved.

4. Near-Term Mitigation Options and Costs – David Black

David discussed the proposed restoration of the South and North portions of Southern Glades Parcel #1. Parcel #1 South is approximately 100 acres of moderately dense exotics with no scraping recommended. Parcel #1 North is approximately 240 acres of dense exotics where scraping would be beneficial to the proposed restoration. A proposed restoration plan and

estimated restoration and long-term management costs were discussed.

David suggested using a forestry mower/shredder to clear access pathways through the dense Ardisia and Brazilian Pepper, to allow access for surveying. The survey information would help in developing a more accurate restoration cost estimate. Terrie Bates made a motion to expend up to \$37,000 for the initial clearing and surveying activities at Parcel #1. Leah seconded

the motion. Motion passed.

Marjorie Moore said the project had been discussed with the District's CERP group and they told her that there was a low probability of CERP construction on the site and that if there was CERP construction in the future, that CERP would take responsibility for offsetting any

impacts to the proposed mitigation project.
