3. Review and Approve minutes from 02/26/10 meeting – Terrie Bates

Minutes were reviewed with no corrections. Motion to pass the minutes as prepared, was approved.

4. Funding for Testing & Evaluation of L-31 Seepage Pilot Project – Tom MacVicar

Tom discussed the summary of expenditures to date for the test seepage barrier construction and the cover memo requesting the authorization to spend \$167,870 to conduct the tracer test of the seepage barrier field test at the L-31N site. Two items are attached to the memo; The Proposed Study Plan for the Dye Testing of the Test Wall, and the agreement on the well drilling for the monitoring sites for the tracer test.

Matt Davis commented that DERM was not involved with the initial proposal for the L-31 Seepage Pilot Project or the proposed tracer test. He is now being asked to approve additional funding without adequate time to review the tracer test proposal. Matt requested that in the future, the committee members receive proposed funding requests and supporting documents at least three weeks in advance of the committee meetings. Terrie indicated that, when possible, the committee will endeavor to meet this request.

Action 1 - A technical meeting to review the proposed study was scheduled for Wednesday, May 26, 2010 at 1:00 PM. Additional background information will be sent out to the identified technical representatives prior to this meeting. The purpose of this meeting is to

review the proposed study for the dye testing of the test wall in preparation for reconsideration of

the funding request at the June 11, 2010 LBMC meeting.

5. Design Contract for Access Road along FPL Corridor – Tom MacVicar

Tom reviewed the memo requesting the authorization to spend \$194,400 for the

engineering design and surveying costs for the FPL access road construction to be used in the

plan to provide seepage mitigation for the central Lake Belt Area. This is a time sensitive issue

as Special Condition 24.a of the new Corps permits requires construction of the FPL access road

by early 2012. The engagement letter and first task order for the design firm are attached to the

memo.

A motion was made to approve \$194,000 funding for engineering design and surveying

costs for the geotech proposal, but not the access road design. Motion approved.
