SUBJECT: Operational Position Statement for February 9, 2016 to February 15, 2016

This Position Statement is for the one-week period from February 9 through February 15, 2016. On February 8 the Lake Okeechobee stage was 16.40 feet, NGVD, in the Intermediate Sub-band of the 2008 LORS. During last week the Lake stage experienced an increase of 0.26 feet.

District wide rainfall for the month of February to date is above average. Rainfall for the upcoming week is forecast to be below average and average for the following week.

<u>Forecasts</u>: Consistent with the forecast associated with strong El Niño conditions, the most recent Climate Prediction Center (CPC) outlook for Central and South Florida indicates an increased likelihood of abovenormal rainfall (65%) for the month of February 2016, and increased chances of above-normal rainfall (65%) for the three-month window February to April 2016. The CPC rainfall outlook for the March to May period also shows an increased likelihood (55%) for above-normal precipitation.

<u>2008 LORS Release Guidance (Part C)</u>: With the Lake Okeechobee stage within the Intermediate Subband and stages in WCA-2A and WCA-3A higher than the maximum of their respective schedules plus 0.25 feet, Part C of the 2008 LORS release guidance recommends "No Releases to the WCAs".

Over the 7-day period from February 1, 2016 to February 7, 2016, no releases from the lake south to the STAs were made. Releases from the lake to tide via C-10A, L-8 and C-51 did not take place either.

Given the outcome of Part C, no Lake Okeechobee releases to the WCAs will be implemented during this week. In addition to the high stages in the WCAs, other factors contributing to this outcome are remaining runoff using the EAA canals' capacity, continued high stages in the STAs (above target stages), lack of storage in the A-1 FEB and current wet conditions.

<u>2008 LORS Release Guidance (Part D):</u> With the Lake Okeechobee stage in the Intermediate Sub-band, Part D of the 2008 LORS release guidance recommends "S-77 up to 6,500 cfs and S-80 up to 2,800 cfs". The SFWMD recommendation to USACE is to follow the 2008 LORS.

In the St. Lucie Estuary, salinity during the past week remained in the poor range for adult oysters. In the Caloosahatchee Estuary, salinities at Sanibel remained in the good range for adult oysters. Salinity at Shell Point continued to decrease and entered into the fair range. Salinity at Cape Coral remained in the poor range.
