Procedures for assuring quality sample collection

#### Mandates

- Mandates for monitoring ENP include the EFA, Settlement Agreement, NECP Permit, and the C111D Emergency Order.
- These legal documents provide high level guidance over monitoring requirements including structures, parameters and occasionally frequencies.

## **Monitoring Plans**

- Monitoring plans are interpretations of mandates into specific, usually geographically based projects.
- Monitoring plans specify stations, station coordinates, parameters, sampling frequencies, and any project specific deviations from the Field Sampling Quality Manual.
- Projects associated with ENP include EVER, ENPF, ENPW, ENP, C111D, TAMB, CAMB, and NECP. Current draft monitoring plans are being consolidated into a final integrated plan.

## Field Sampling Quality Manual

- The manual is an agency specific document that specifies
  - Sample collection procedures
  - Field testing procedures
  - Quality control requirements
  - Decontamination procedures
  - Documentation requirement
- The manual complies with the FDEP rules.
- Manual may be supplemented or clarified with activity specific SOPS.

## Monitoring for ENP Inflows

• Majority of work contracted out to Miami-Dade County

Department of Environmental Resources Management

- follows FDEP QA rule and SOPS.
- maintains an agency field sampling quality manual.
- follows SFWMD manual when collecting samples for the SFWMD.
- maintains training documentation and records for all sampling personnel.
- Miami-Dade work products are reviewed by SFWMD staff, including contract manager, project manager, and laboratory receiving.
- SFWMD meets with Miami-Dade for informal discussions, formal contractual issues, training, field visits, and audits.

#### Miami-Dade Audit Results

- Miami-Dade was audited on 1/26/05.
- Field sampling procedures were deemed adequate.
- Minor deficiencies requiring corrective actions were appropriately addressed.

## Monitoring for ENP Interior

- Majority of work contracted out to ENP Staff
- ENP work products are reviewed by SFWMD staff, including contract manager, project manager, and laboratory receiving.
- SFWMD meets with ENP for informal discussions, formal contractual issues, training, field visits, and audits.

#### **ENP** Audit Results

- ENP was audited on 12/15/04.
- Some field sampling procedures were deemed of concern.
- Deficiencies requiring corrective actions are being addressed.
  - ENP Quality manual is in draft
  - Procedures to maintain training records are being developed
