1. Call to Order

The meeting was called to order by Sharon M. Trost at 10:03 a.m. Ms. Trost reviewed the purpose and requested all comments be regarding regulatory issues and introduced staff at Headquarters and the service centers. There was one members of the public present at District Headquarters in West Palm Beach and one member of the public participated over the phone; no members of the public were present at any of the service centers.

2. Applications of Heightened Public Concern Pending Final Action

Application 130325-12 Collier 22-3H

Public Comment: Martha Musgrove representing Florida Wildlife Federation inquired regarding this application, more specifically in regards to the depth of the wells. Ms. Musgrove also expressed concern with any potential environmental impacts.

Staff responded that the application is for two water supply wells from the Lower Tamiami Aquifer that will be 100 feet in depth. The wells will be used as supplemental water supply for the drilling of the oil well; although the permit will be issued for five years, its duration only allows water use for 70 consecutive days and a monthly allocation of 5 million. The permit will also include a condition that will require the well to be abandoned after its permitted use.

Application 130325-10 Miami Quarry

Public Comment: Alex Larson inquired regarding this application

5. Public Comment on General Regulatory Issues
